## Na covo hna: Na ngandamnak kongkau asi pohpoh ahcun, covo dik pawl na ngei ko.

Naa thlopnak kongkau (medical record) cu catlap siloah electronic-thil in lak khawh na si.

- Sii naa thlopnak kongkau (medical record) cu catlap in siloah electronic thil in lak ding siloah zoh ding ah na hal khawh. Zeitindah hal ning si kha rak kan hal.
- Na hal hnu ni 15 chungah, na ngandamnak kong tawi-fiang cu kawpi (copy) in kan in pek lai. Mah lakanak ah aa tlak zat tangka kan in lak lai.

**Na sii thlopnak kongkau (medical record) kong remhpiaknak hal khawh asi.**

- Na ngamnak kongkau ah a dik lo tiah na ruahmi cu remhpiak dingah na hal khawh. Zeitindah hal ning si kha rak kan hal.
- Remh ding na kan halmi cu “kan remh lai lo” tiah kan in ti khawh men, cuti kan tinak aruang cu ni 60 chungah kan in fianh lai.

**Na kan pehtlaihnak cu a thup in tuah dingah hal.**

- A dang tein pehtlaihnak tuah ding (tahchunnak ah, inn fon si lo ah zung fon) siloah hmundang (address)ah caa kuat-ter khawh asi.
- Na halmi cu asi khawh chungin “si, kan in pek” lai kan ti lai.

**Na kongkau kan hmannak le hromhnak rikhiah dingah kan hal.**

- Na ngandamnak kongkau cu thlopbulnak, man peknak, siloah, riantuannak caah hman le hromh lo dingin na kan hal khawh. Na kan halmi hi tuhpiak dih ding ti si lo, kan in thlopnak a hnorsuang khotu si cun “kan in tuahpiak kho lo” kan in ti ko lai.

- Naa thlopnak man nangmah tein naa pek ahcun, cu kong cu nangmah aa-mah-khan kampani le kanmah karlak tangka peknak le riantuannak chungah hman le hromh lo dingin na kan nawl khawh. Cu kong cu upadi nih langter uh tiah a kan fial lo poh ahcun, “si, kan langter lai lo” tiah kan in ti ko lai.

### **Na kongkau kan hromh cangmi hna phu cazin na lak khawh.**

- Naa thlopbulnak kong kan hromh ciami hna a dang phu cazin cu na kan hal ni in a liamcia kum ruk chungah kan rak hromhmi hna phu cazin, cun zeiruangah dah kan hromhnak timi kong na kan hal khawh
- Hromhmi chungah thlopbulnak, tangka peknak, kan in zohkhenhnak kong, le a dang langter lo ding (na kan halmi pawl) pawl cu hromh an si. Kum kha ah voikhat cu a lak tein kan in pek ko lai nain, thla 12 chungah a dang na kan halthan rih ahcun a mah he aa tlak zat in tangka kan in lak lai.

### **Pumpak Kongkau ah Theihternak Kawpi (Copy) hi i lak.**

- Mah pumpak konglam theihternak catlap hi electronic thil in lak dingah na hnatlak cang zongah kawpi zeitik poh ah na kan hal khawh ko. Catlap kawpi cu a rannak in kan in pek lai.

### **Nangmah ai-awhtu mi pakhatkhat thim.**

- Nangmah sithlopbulnak biachahnak tuah khotu dingah na thimmi, siloah, phungin in nangmah zohkhenhtu nih cun na ngandamnak konglam caah duthimnak a tuah khawh.
- Cawlcahnak kan tuah hlan ah, mah nu/pa cu nangmah ai-awhtu asi ko timi cu kan fehter ta lai.

## **Duh Naa thim Khawhmi: Ngandamnak konglam zeimaw ahcun, kan hromhmi hna kongkau ah na duh thimnak na kan chimh khawh.**

### **Hi kongah cun, a tanglei bantuk duh thimnak le covo na ngei:**

- Na chungkhar, hawikom dawt, siloh ah nangmah zohkhenhtu pawl sin ah chimh dingah na kan hal khawh.
- Harnak bawmhtu sinah na konglam chim ding na kan hal khawh
- Sizung Kawlnak ca-uk (Directory) ah na konglam telh dingah na kan nawl khawh.

*Na duhmi na chim thiampi lo ahcun, tahchunhnak ah mah le mah hngal loin na um tikah, nangmah nih na duhmi si ko tiah kan zumhmi sin ah cun na konglam kan langter ko*

*lai. Ngandamnak le humhimnak caah tihnung asi ahcun, cucus zorter dingah na konglam hi kan langhter ko lai.*

**A tanglei kongah cun nangmah nih catial in nawl awnh-nak na pek lo poh cun na konglam kan langhter lai lo:**

- Tangka kawlnak caah.
- Na konglam zuar dingah.
- Lung leidam lomi thlopnak kongkua caah.

**Kan Hman Ningcang le Langher Ningcang: A tlangpi in na ngandamnak konglam hi a tanglei bantuk in kan langhter siloah kan hman tawn.**

**Nangmah thlopnak ah:**

- Nangmah an thloptu thiamsang sin ah nangmah thlopnak caah tiin na ngandamnak konglam cu kan chimh tawn hna.

**Tahchunhnak ah: Na hliamhma an thloptu siibawi nih na ngandamnak kong he aa pehtlaihmi hna kha a dang siibawi sinah a hal hna.**

**Kan phu rian kal khawhnak dingah:**

- Kan phu rian kal khawhnak, thlopbulnak that deuhnak, le a herh caan ah kan in pehtlaih khawhnak ah na konglam cu kan hman khawh.
- Tahchunhnak ah: Na rian (services) le na ngandamnak thlopnak ding caah na ngandamnak he aa pehtlaihmi thawngpang hna kha kan hman.**

**Na dihmi tangka tuahnak ah:**

- Na ngandamnak zohkhenhtu kampani le a dangdang nih na dih dingmi tangka peknak ding tuahnak caah na ngandamnak konglam cu kan hman.

**Tahchunhnak ah: Na ngandamnak aa-mah-khan kong he pehtlaih mi pawl kha kan in chim fianh lai i cu aa-mah-khan nih a liam ko lai.**

## **Mipi Ngandamnak le Humhimnak Caah:**

- A tanglei thil sinning bantuk in nangmah ngandamnak konglam hi kan langhter khawh:
  - Zawtnak in khamnak caah.
  - Thilchuah (Product) tha lomi khomh suat-thannak caah.
  - Sii thlopnak caah sii-ai ziak lomi kong thanhnak caah.
  - Chungkhar tang tukvelhnak, zoh-khanh lonak, le ruahdamhmi ningcang loin tuahnak pawl kong thanhnak caah.
  - Ngandamnak le humhimnak caah tihnungmi kong khamnak le zoaternak caah.

- Ralkap, rampi humhimnak riantuantu, le president humhimnak riantuantu ti bantuk in cozah rian tuantu sin ah.
